



Now accepting application for the juried competition

The Fall Celebration of the Arts 2010

"An invitational and juried show featuring arts and crafts of this region"

October 9 – November 6, 2010

AWARDS: Up to \$1000 in cash prizes. Entry in this exhibit/competition by an artist means that the artist agrees with the rules and procedures outlined here and recognizes that the juror's decision is final.

ELIGIBILITY: The competition is open to all artists, including traditional and contemporary craftsmen living in Watauga, Avery, Mitchell, McDowell, Yancey, Madison, Burke, Caldwell, Buncombe Counties in NC and Washington, Carter Counties in TN.

FIRST TIME ENTRIES: First time participation in the FCA requires that you submit up to 3 digital images on a CD, along with \$35 entrance fee (checks made out to TRAC), a completed Inventory and Jury Action Card (see the bottom of page).

PREVIOUS PARTICIPANTS: Previous FCA participants from Avery, Mitchell or Yancey Counties are eligible for awards. A \$35 fee must be paid upon delivery of work. Inventory pieces with name, title, media, and price. Deadline for receipt of work is Oct 2.

IMAGES (CD): Submit one high resolution digital image per work and label each with: 1-Name of artist, 2-Title, 3-Size, 4-Date of completion, 5-Medium. Works for the show will be judged by digital images on CD only. Images should not be manipulated. Prizes will be determined after the show is hung.

JUROR: Hank T. Foreman is an artist, art administrator and educator. He is currently employed by Appalachian State University in Boone, NC where he serves as Associate Vice Chancellor University Communications and Cultural Affairs, administering the programs of An Appalachian Summer Festival, the Performing Art Series, the Turchin Center for the Visual Arts, as well as Public Affairs, Marketing and Communications Design, and Creative Services.

ACCEPTED WORK: Accepted entries/invitational work must be hand delivered to the TRAC Spruce Pine Gallery, 269 Oak Avenue in Spruce Pine between 10 and 5 pm, Sept 27- Oct 2. Pieces not ready for hanging or display will not be accepted.

LIABILITY: The sponsors of this exhibit will make all reasonable efforts to protect all works received from damage. Our current insurance covers the wholesale cost of artists' work.

SALES: Sales will be encouraged. A 40% commission will be retained.

REMOVAL: All works must remain on view until the close of the exhibition or until sold. Works must be picked up Nov 8-13.
